



EPA and Partners Metadata Training Project Training Session Information

The EPA and Partners Geospatial Metadata Project will provide comprehensive metadata training and instruction for EPA's geospatial community (personnel, contractors, and grantees), other (non-EPA) federal agencies, state agencies, tribes, and additional groups (e.g., organizations, academia, local government agencies, and/or private companies). Any interested party is invited to join.

There will be 3 courses (introductory, intermediate, and EME 3.0 specifically), each of which will have 2 offerings.

Accessing the Sessions:

All trainings **except** the hands-on training session in DC will be conducted using web-cast and teleconference. No special tools or software are required except a web browser and a high-speed internet connection. We will be using EPA's Oracle Portal for the web conference. The web conference feature does require that users install the Oracle Meeting Manager in advance. This can be done at the time of access. It is recommended that you access the web conference information 10 minutes prior to the start of the meeting so that you have time to enter your information and configure the meeting manager on your machine (if necessary). You may pre-enroll, but you will likely still have to re-enroll when you actually access the conference.

Session Content:

The training series will be conducted in three different sessions; an introductory session, an intermediate session, and a session that will focus specifically on the EPA Metadata Editor (EME) version 3. Each session will be broken down into modules. Most modules will have some hands-on demonstrations and samples where the user can follow along. All materials will be placed on the Innovate website (<http://innovateteam.com/projects/epa-and-partners-geospatial-metadata-training/>) prior to the training so that attendees can download the information if they would like. There is no need to download the information in advance; everything will be presented in the web-cast. However, if users would like to follow along on their own machines, they will be able to using the samples provided. More detail about each session is provided below.

Introductory Training: the introductory training will provide attendees with an introduction to the FGDC standard and FGDC compliancy as well as how to use various tools (e.g., a metadata implementation, templates, and editors [specifically the use of the EPA Metadata Editor]) to improve metadata production. This session will also introduce the North American Profile (NAP) of the ISO 19115/19139 standard and will discuss how it relates to the FGDC CSDGM. This session is designed for users who do not have a lot of knowledge about the FGDC standard and its structure or about creating an implementation, using templates or using the EME. It is also intended for users who would like to know more about the NAP of the ISO 19139/19115. It does not cover why someone should develop metadata or what the business case for metadata is; it is assumed that most users already know they want to create metadata and need more information on that process.

Intermediate Training: the intermediate training will provide attendees with a quick overview of the basics learned in the intro course (FGDC CSDGM, compliancy, creating an implementation and using templates) and will then focus on advanced use of the EPA Metadata Editor (EME), sharing information via metadata catalogs, and how to contribute to Geospatial One Stop. The advanced use of the EME will include a demonstration of how to modify the database for specific user needs. This demonstration will show the State of North Carolina's implementation. It will also provide a detailed overview of how EPA set up their geospatial data portal, called the GeoData Gateway (GDG) to serve internal and external sharing needs. It will describe the configuration and the challenges faced in implementing an enterprise catalog as an example of how to implement a Portal Toolkit catalog and will feature a live demonstration of the site and its components. Other catalog implementations will be described and compared against the use of ESRI's Portal Toolkit software. This training session assumes that attendees have a decent understanding of the FGDC CSDGM and how to create metadata.

EPA Metadata Editor (EME) 3.0 Training: the EME 3.0 training will focus on how to use version 3 of the EPA Metadata Editor. It will provide an overview of the new features and how they work. Specifically, this training session will cover the following new EME features:

- Using the new EPA Metadata Validation options
 - batch validation
 - highlighting errors within the user interface
 - separating errors from warnings
- Configuring the path to the EME database
- Using the new help features

- Entering user-defined keywords
- Editing attributes
- Entering multiple dates in the time period information field
- Removing ESRI tags
- Using global search and replace
